

RESOLUTION 2021-1
FLATHEAD IRRIGATION DISTRICT

A RESOLUTION CALLING FOR FLATHEAD IRRIGATION
DISTRICT 1 Election

WHEREAS, SECTION 85-7-1702 MCA, requires that one Commissioner position of Flathead Irrigation District is to be elected and can only be appointed if no nominations are made for irrigator Commissioner of District 1 (Moiese).

WHEREAS, Section 13-1-502, MCA, requires candidates for the office of Commissioner for District 1 to file a Declaration of Nomination and Oath of Candidacy at least 85 days before the election day; and

Whereas, Section 13-1-504, MCA requires the election to be held on school election day, which is May 4, 2021; and

Whereas, the election may not be held earlier than 85 days after the date of the order or resolution calling for the election pursuant to 13-1-504, MCA; and

WHEREAS, 13-15-504, MCA, requires the governing body to specify in the order or resolution calling for the election whether the election is to be conducted by mail or by polling place; and this election will be by mail.

WHEREAS, the trustees of the Flathead Irrigation District have determined that the commissioner position will expire in May, 2023, and

WHEREAS, the trustees find that it is necessary to elect One Commissioners at the election in 2021.

NOW THEREFORE, BE IT RESOLVED:

1. A trustee election for the FLATHEAD IRRIGATION DISTRICT One Commissioners shall be elected on May 4, 2021.
2. Declarations for Nomination and Oaths of Candidacy for candidates for District 1 may be filed with the Lake County Elections Office no later than 5:00 pm February 8, 2021. If, after the write in candidate filing deadline of February 8, the number of candidates is equal to or less than the number of positions to be elected, Toni Kramer Election Office Administrator shall declare elected by acclamation for candidate who filed for a position. If a nomination is not made for one trustee position, the Chairman of Flathead Irrigation District, Paul Guenzler shall appoint one or more trustees as necessary to fill the position.

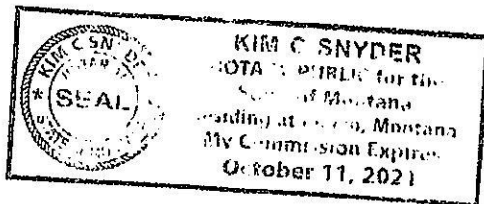
